57/21 Adoption of the Town Council Minutes of June 1st 2021:

The minutes were **adopted** with all in favour.

58/21 Clerk & External Funding Officer Update:

The clerk reported that interviews had taken place earlier in the day for the Town Centre Officer with three excellent candidates. Fiona, the External Funding Officer had also successfully bid for £10K from the National Lottery Heritage Fund for the launch of the Wold Rangers Way.

61/21 To consider a request from Driffield Town Football Club for a donation from the Small Grant Fund:

The new football club was welcomed, however the clerk was asked to inform them that once they were affiliated to the FA and had their own bank account in operation then their request would be considered.

To consider launching a press campaign to encourage residents to phone 101:

After considerable discussion it was **agreed** with all in favour that a poster be designed to encourage residents to ring the police to report instances of crime, anti social behaviour etc which could be promoted on our social media platforms.

To consider a resolution to seek external funding for Driffield Youth Action:

It was <u>agreed</u> with all in favour that the External Funding Officer meet with the Driffield Youth Action committee and to plan a way forward and identify potential projects for which funds could be acquired and also release the £10K earmarked for youth projects in the DTC's match funding budget.

To consider the future of Cass Hall as a performance space/community cinema venue:

The recent Commonplace Engagement consultation had highlighted the positive response to the idea of the provision of a community cinema. DWCC had identified Cass Hall as an ideal venue and there was funding available from various sources to pursue this further. It was **agreed** with all in favour that this idea be explored for the Cass Hall.
