# 102/21 Acknowledge receipt from ERYC of the confirmation of nomination of the Alfred Bean Hospital as a community asset and update on Healthy Towns:

# 103/21 To consider a request for funding from the Driffield Skate and BMX Park:

It was <u>agreed</u> with all in favour that the £2200 received from the Horace Taylor Trust towards the new LED lighting be matched from the DTC Match Funding Pot if the External Funding Officer was unable to secure funding from elsewhere.

# 104/21 To consider a request from Great Driffield Radio for a donation from the Small Grant Fund for the Driffield Young Reporters Project:

It was <u>agreed</u> with all in favour that £500 be donated. The clerk explained that the Young Reporters would provide essential help in consultation work with the young people of the town that was needed by the External Funding Officer to evidence her bids for funding. The council were also informed of the possibility of a youth council being established and they were keen to facilitate assistance from both the clerk and the External Funding Officer, as well as use of the Market Walk meeting room if needed.

It was **agreed** with all in favour that a defibrillator be purchased.

#### 106/21 To consider the issue of Scrambling 2022:

It was <u>agreed</u> with 11 in favour and 2 against to refer the issue to the Events Committee and it was suggested that December 31<sup>st</sup> be the date chosen, it was also thought that the COVID situation did not require consideration.

The conclusion of audit was **agreed** with all in favour.

### 108/21 To consider the issue of street cleansing in the town centre:

After considerable discussion it was **agreed** with all in favour to approach the ERYC with regard to the introduction of a Service Level Agreement whereby the DTC take over the street cleansing of the town centre.

#### 109/21 To agree the Media Policy:

Cllr A Coleman voiced concerns re: the intention to create the Discover Driffield social media pages as he felt adequate administration of too many

social media sites would be challenging. It was however felt this this was an essential remit of the TCO role to market and promote the town this way.
