MINUTES OF THE DRIFFIELD TOWN COUNCIL MEETING HELD ON TUESDAY 6 JUNE 2023 IN THE COUNCIL CHAMBER, THE COMMUNITY CENTRE, DRIFFIELD

Present: Councillors F Smith, S Starrett, G Lucas, T Watson, A Newall, K Stack, M Rogers, G Helliwell, M Blakeston, P Rounding, and Town Clerk M Brown

PCSO Claire Watson explained that ASB was up slightly and several vehicles had been interfered with. Many "sneak in" burglaries had been reported around the town and villages and on investigation many of these buildings had not been locked.

The passive drug detector dog had been used and a small amount of drugs had been recovered.

Active Friday was progressing well with 26 young people being engaged. These Fridays will continue up to the 30 June.

Regarding the additional Police for Driffield, experienced officers will be deployed once the current Police station has completed its improvements with items such as IT. No time frame can be given. Cllr Rogers stated this needed a quicker response as 4 months in, sooner or later, residents may start asking for a refund of the additional precept being paid.

Cllr Rogers proposed to ask all co-option candidates to leave the chamber prior to voting. This was <u>agreed</u> with all in favour.

Cllr Blakeston gave an outline of the basis of the evening which was positive and well attended. This was echoed by Cllr Watson who added how impressive it all looked.

50/23 Update on The Big Picture Consultation Event

The "live" painting consultation went well with much public interaction. The finished work will be placed on display in No.43. Cllr Rogers would like the artist to see the RAF painting within Alamein Barracks and will endeavour to arrange this.

51/23 ERNLLCA Councillor Training Dates

From the options given, it was <u>agreed</u> for the clerk to try and arrange these for 5 July at the Market Walk offices.

52/23 To consider a resolution to feature Town Council buildings on a proposed map at Market Walk for a 50% contribution of total costs

Cllr Rogers stated that this would not be in any budget. Cllr Blakeston stated that we can't set a precedent by assisting to update one window, yet not others.

Cllrs Blakeston and Cllr Rogers felt the matter should be referred to the Property and Assets committee for discussion alongside the Market Walk boxes.

53/23 Invitation to arrange a meeting to hear progress from Great Driffield AFC

Cllr Blakeston thought it would be good to have a meeting to hear their ambition plans and was happy for a letter to be sent. This was <u>agreed</u>, but wanted it to be noted that no budgeted funds where available. The clerk was to ask if the EFO could assist. Cllr Rounding stated that the site is well attended, by those playing and watching.

To consider a request for funding from the Small Grant Fund from Driffield Town Bowls Festival

Cllr Stack felt this should not be supported and that other groups should be able to benefit from the small amount of funds available. Cllr Starrett suggested that the funds requested should be given as we have already donated to another bowls group at the same location. It was **agreed** to grant a donation of £200 on this occasion, but a similar arrangement may not be available next year.

To consider a request for funding from the Small Grant Fund from the Driffield Ukulele Band

Cllr Blakeson explained that the band are a real credit to the town and would benefit from a donation of £500. This was <u>agreed.</u>
